OCT. 27, 2020: TRAIL SUMMIT REPORT RELEASED

At virtual presentation by author and photographer Dudley Edmondson on the divide between outdoor activities and people of color. Top priorities were Fox Cities to High Cliff State Park, Neenah to Oshkosh and Kaukauna to Green Bay. Also premiered video of Loop the Locks Trail.



FALL OF 2020: COVID SENDS PEOPLE OUTDOORS Fox Cities residents found the solution to going stir crazy from sheltering in place was to get out and walk the trails. Trail usage at least doubled in most places.



Evergreen Drive Trail: Grand Chute, \$132,000, links Town Hall to Meijer retail area in 2021





Lawrence University's Riverwalk Trail





Lawrence University will invite the community onto campus with a paved and lighted trail from Lawe Street to Drew Street along the Fox River with an observation deck on the Drew Street end.

\$1 million

Support includes \$100,000 from the Community Foundation's David L. and Rita E. Nelson Family Fund and a \$156,670 estate gift.



Lawe Street Trestle | 2020 | \$1.4 million Connects Lawe Street and North Island Trail to Lawrence University, Eagle Point Senior Complex, Newberry Trail and John Street.

Lutz-Vulcan Boardwalk | 2025 | \$2 million Runs along north bank of Fox River connecting Lutz and Alicia parks to North Island Trail and Newberry Trail, and future Ellen Kort Peace Park and Nelson Bridge.

Ellen Kort Peace Park and River Trail Appleton, \$2 million

2022 Phase I (grading, exterior trail, lighting) \$750,000 (Outagamie County Greenways \$50,000) 2024 phase 2 (shelter, parking, landscaping, interior trails, gardens)


